## Restricted Area Resolution

The Board of County Commissioners of Madison County, Ohio, met in regular session on the 12 of September, 2023, at the office of the Madison County Commissioners with the following members present:

<u>Oh Jong Yenikis</u> moved for adoption of the following Resolution:

WHEREAS, pursuant to Ohio Revised Code § 303.58 and 303.59, a Board of County Commissioners may adopt a restricted area resolution;

WHEREAS, at least thirty days prior to the meeting on September 12, 2023, at which a resolution to designate a restricted area will be discussed, the Board of Madison County Commissioners did all of the following:

- (a) Provided public notice of the date and time of the meeting by one publication in a newspaper of general circulation within the county;
- (b) Publicly posted a map showing the boundaries of the proposed restricted area at all public libraries within the county;
- (c) Provided written notice of the meeting, by first class mail, to all school districts, municipal corporations, and boards of township trustees located in whole, or in part, within the boundaries of the proposed restricted area.

WHEREAS, included within this resolution is a map, as well as, text sufficient to identify all boundaries of the restricted area in accordance with Section 303.58(D).

WHEREAS, upon adoption, a copy of the resolution and any accompanying texts and maps shall be filed with the office of the county recorder of the county, in accordance with Section 303.58(D);

WHEREAS, adoption of this resolution designating a restricted area prohibiting the construction of utility facilities shall become effective thirty days after the date of adoption on September 12, 2023; in accordance with Section 303.59;
