PERMITS AND INSPECTIONS ARE REQUIRED FOR ANY OF THE ABOVE HEATING AND COOLING EQUIPMENT BEING INSTALLED IN EXISTING OR NEW HOUSES OR ACCESSORY BUILDINGS.

-- "ATTENTION" -- SPECIAL NOTE -- "ATTENTION" --

IF A SCHEDULED INSPECTION IS NOT COMPLETE WHEN THE INSPECTOR GOES OUT TO INSPECT, A "\$45.00" REINSPECTION FEE WILL BE CHARGED AND MUST BE PAID BEFORE ANY MORE INSPECTIONS CAN BE SCHEDULED. ALSO, WORK IMPROPERLY DONE AND SCHEDULED FOR MORE THAN ONE REINSPECTION WILL BE CHARGED A "\$45.00" FEE EACH TIME THAT IT HAS TO BE REINSPECTED. FEES MUST BE PAID BEFORE THE INSPECTION WILL BE DONE.

ON SITE CONSULTATION FEE: \$45.00 FOR EACH CONSULTATION

TO REGISTER WE REQUIRE:

1. COPY OF LIABILITY INSURANCE CERTIFICATE SHOWING COVERAGE (MINIMUM COVERAGE \$100,000/300,000 - BODILY INJURY / \$25,000 PROPERTY DAMAGE.
2. IF ANY EMPLOYEES, SUBMIT A COPY OF CURRENT WORKERS COMPENSATION CERTIFICATE.
3. **\$200.00 REGISTRATION FEE. \$100.00 RENEWAL FEE.**
